### LEI MUNICIPAL Nº. 705/2012

**SÚMULA:** “ALTERA DISPOSITIVOS DA LEI MUNICIPAL Nº. 238/2003 E DÁ OUTRAS PROVIDÊNCIAS”.

A CÂMARA MUNICIPAL DE CARLINDA, Estado de Mato Grosso, no uso de suas atribuições legais, aprovou e eu, Orodovaldo Antônio de Miranda, Prefeito Municipal, sanciono a seguinte Lei:

**Art. 1º** - Altera os incisos III e IV do art. 44, da Lei Municipal nº. 238/2003, que passará a ter a seguinte redação:

**Art. 44.** -----

**III** - de uma contribuição mensal do Município, incluídas suas autarquias e fundações, definida na reavaliação atuarial igual a 14,40% (Quatorze inteiros e quarenta décimos percentuais) calculada sobre a remuneração de contribuição dos segurados ativos;

**IV** - adicionalmente a contribuição de que trata o inciso III deste artigo, todos os órgãos de poder do município, inclusive nas autarquias e fundações, a título de recuperação do passivo atuarial e financeiro, contribuirão na alíquota a razão de 1,54% (um inteiro e cinquenta e quatro décimos percentuais) incidentes sobre a totalidade da remuneração de contribuição dos servidores ativos, nos termos do inciso I e II, até dezembro de 2046, conforme tabela anexo a essa lei;

**Art. 2º** - Os demais dispositivos da Lei Municipal nº. 238/2003 permanecerão em vigor.

**Art. 3º** - Fica o Executivo autorizado a proceder a reedição da Lei Municipal nº. 238/2003, com as alterações da presente Lei.

**Art. 4º** - Esta Lei entrará em vigor a partir da data de 1º de julho de 2012, ficando revogadas as disposições em contrário.
